#### Marylebone News

Baker Street and Gloucester Place Two Way



Last weekend the switch over to two way traffic occurred. After 40+ years of one way traffic, it will take a while to get used to! Obviously, please look in both directions when crossing the road - it is worth waiting for a green man. The scheme will take a while to bed in and further works are still to be undertaken including more tree planting and central islands that are still to be added. Work has now stopped for 6 weeks but all work should be completed by June. The lack of pedestrian crossings at George Street and Gloucester Place has generated much of the initial feedback and we understand this is being reviewed. It is worth remembering that the scheme is

meant to be traffic neutral. Please let us know your views particularly on any displaced traffic problems. TfL has not managed the bus information very well, signs at the bus stops and spider maps are all need updating. We expect these will get addressed in the coming weeks. #### Marylebone High Street Low Emission Neighbourhood Scheme




As part of the Marylebone Low Emission Neighbourhood scheme, works are taking place along Marylebone High Street (no road closures are planned). The photo on the left shows the completed "rain garden" on the High Street.

From Monday 18th March, Paddington Street (outside the gardens), will be closed to traffic for approximately two weeks to facilitate drainage works. During this time, westbound traffic will be diverted along Nottingham Street, Marylebone High Street and Marylebone Road; whilst eastbound traffic will be diverted through Chiltern Indexberg Like Street

Street, Manchester Street, Blandford Street and Marylebone High Street.

An idea first raised by the Marylebone Association to create more space for the Marylebone Library by co-locating it at the Seymour Leisure Centre, might be moving a step closer. A very similar scheme in Poplar Leisure Centre has been successfully undertaken and we would very much like to see it replicated in Marylebone. It has the potential to solve our swinming pool issues along as well as providing more space for the Library and maintaining a soft play area for small children.

Westminster Cabinet approves new Oxford Street District plans

Last week Westminster City Council's Cabinet approved an update to the 'Place Strategy and Delivery Plan for the Oxford Street District' and the proposed budget of £150 million to support the scheme.

The Council consulted on its draft Strategy between 6 November and 16 December. This promoted a set of 15 overarching place-based principles and 96 projects, generating the highest ever number of responses to a Council led consultation: 2,154 people completed consultation responses, with support from 66% of respondents overall and 73% of residents. However, the overall support did not extend to certain proposals to close Oxford Circus and restrict other parts of Oxford Street to non-bus traffic. The Marylebone Association generally welcomes the new Westminster Council approach to the whole district but has expressed concern about this part of the plan and objected to it in the recent consultation, as did our neighbouring Amenity Societies in Mayfair, Fitzrovia, Soho and elsewhere. These societies are all members of the Better Oxford Street group and its response to the plans can be found here.

The budget will go forward for approval at the April Cabinet, then following further design development, stakeholder engagement and traffic modelling, Westminster Council anticipates commencing work on the first tranche of projects in Autumn. ### Phoneboxes lose Permitted Development Rights

The High Court has quashed a planning inspector's consent for a new telephone kiosk in central London after a judge ruled that such structures served a 'dual purpose' of both communications and advertising and therefore should not benefit from permitted development rights. Over the last two years Westminster City Council rejected 170 applications for new telephone kiosks. If all of these applications had been approved there would be one phone box every 15 metres along Edgware Road! Processing these applications is time-consuming and costly. Well done to Westminster City Council and our own Cllr Richard Beddoe for fighting this issue on behalf of residents. A great result for Marylebone but also for London and the whole country.

#### CS11: Court of Appeal uphold Westminster's Judicial Review

The Court of Appeal have upheld High Court judge Sir Ross Cranston's ruling that the controversial CS11 cycle route is unlawful in its current form and denied Transport for London (TfL) permission to appeal further. TfL will be forced to go back to the drawing board as they have now exhausted all legal options available to them. Last September Sir Ross ruled in favour of Westminster Council who had challenged the route in a judicial review at the High Court. His ruling focused on a lack of modelling of the traffic impacts of constructing just the Swiss Cottage portion of the route. In his 16-page judgement, he said TfL's plan to start work at Swiss Cottage before they had consent for the entirety of the scheme was unlawful – as CS11 was planned as one continuous route. CIII Tim Mitchell, Westminster's environment and City Management Chief said it was "time for TfL to get around a table with us". He added: "We're pleased with another decision supporting the council and residents' right to be heard on CS11. We're worried that CS11 in its current form will cause traffic congestion and lead to poorer air quality. We fully support safe cycling and are making major investments for cyclists within Westminster. We're not anti-CS11 or cycling, but we want TfL to take the time to deliver something that works for both cyclists and residents."

# Luxborough Street Campaign

A campaign to save a sports pitch from the bulldozer says that a petition signed by 800 people has been completely ignored by Westminster councillors, according to the <u>West End</u> <u>Extra</u>.

Cllr Rachael Robathan, the Council's Cabinet Member for Finance, Property and Regeneration, said: "We're still talking to local residents about potential options for this site and no decisions have been made. A second round of consultation events will be held in order to understand residents views on any proposals.. we will carefully consider everyone's view before reaching any decision on the future of this site."

#### Rough Sleeping

Streetlink (https://www.streetlink.org.uk) iis an online tool that allows members of the public to report rough sleepers. Streetlink then delegates the report to a local team (in this case our Westminster Outreach service). If the rough sleeper is new to the streets and is not already being supported, the Outreach team will visit the sleep site to verify the report and start working with the rough sleeper. It should be noted that this does not necessarily guarantee the sleeper will work with the support offered straight away, often an entrenched sleeper or sleep site will already been known to the team and those who are working on the case. However, it does ensure that members of the public have the opportunity to report concerns and get some reassurance that the services are aware and working toward a solution.

# Victoria Coach Station move to Royal Oak, Paddington

More than 2,000 people have signed petitions against moving the Victoria Coach Station to a site at Royal Oak, near Paddington. The Marylebone Association remains strongly against TfL's plans as the move would result in thousands of polluting coach moving through and around our neighbourhood.
