

Covid Update - Local Cases dropping back



Local Covid cases appear to be heading in the right direction over the course of January.

The mass vaccination programme, the biggest ever undertaken by this country, is underway. In Westminster, the Community Vaccination Centres at Lord's and Vincer Square opened recently to elderly residents. These are not walk-in facilities; patients need to be registered with a local GP and have an NHS number to qualify. They will advised by their GP and North West London CCG when to turn up for their vaccinati

This first stage of the vaccination programme is on track for the top four priority grou - care home residents and staff, residents 80 and over plus health and social care workers, those 75 to 79 and finally those 70 to 74 plus clinically extremely vulnerable individuals but not including pregnant women and those under 16 years of age - to receive their first dose of the vaccine by mid-February. Both testing and vaccination centres are crucial in the fight against COVID. Westminster offers two types of testing for people with and without symptoms.

For those without symptoms, these testing sites are open without appointment even dav:

For those with symptoms (a new persistent cough, high temperature or a loss or change in sense of smell or taste) appointments are available at these semipermanent, walk-through testing centres in Westminster:

They are open seven days a week, from 8am to 8pm. They can be used by anyone with symptoms or who has been asked to get a test. A test must be booked in advar at NHS Online or by calling 119.

If you live in Marylebone and need to self-isolate and require help with shopping, pharmacy collections, or just a chat about Covid-19, our support group is there for y and has many volunteers ready to help. You can get in touch at Covid19@marylebone.org or phone: 07950 472916.

The Party's Over for Illegal Parties

As millions of people and businesses across I ondon continue to make sacrifices to

help stop the spread of COVID-19, a small number of rule-breakers have driven a rinillegal gatherings and pop-up nightclubs across the city, ignoring essential public health guidance and putting local communities at risk.

Last weekend, council officers were alerted to a location on Edgware Road at which more than 150 people were found drinking, smoking and partying, complete with a E setup. Each attendee was presented with a £200 fine, while the DJ was served with £10k fine as well as having their music equipment seized. The council is also pursui a venue closure notice, which would remove the opportunity for organisers to rearrange future parties and gatherings. The council runs a 24/7 service, so is able t respond to incidents like this quickly. We are always working closely with our police partners.

"Ending unsafe parties and gatherings is a continued challenge for the council," saic Cllr Heather Acton, Cabinet Member for Communities and Regeneration. "We shall keep up our efforts to help curb the spread of COVID-19 across Westminster by stopping these illegal and dangerous events and we thank both the public and the police for their support.

Marylebone Mums and Dads Community and Play

The Marylebone Mums & Dads community is continuing to provide friendship and support to local families during this difficult period with schools shut for an extended period. It would not be an overstatement to say that families are really struggling, especially those with younger, school-aged children. The pressures of combining homeschooling and working, while juggling isolating in small flats without gardens is becoming impossible for many.

Times like this highlight the immense need for public outdoor space and crucially plaspace in the Marylebone area. The short days with limited daylight outside of school hours have meant few opportunities for outdoor play for families, the majority of who have no outside space at home. Timetabled lunch breaks of 40 minutes in some case mean a 15 minute walk to Regent's or Hyde Park is not feasible. Paddington Street Gardens is the only publicly accessible, conveniently-located play space in the area and there have been days when it has been very crowded with social distancing difficult to adhere to. Sadly the loss of the outdoor play space at Luxborough St coul not have come at a worse time - just when people value outdoor space far more that we ever have done.

Looking beyond lockdown, the closure of the Seymour Leisure Centre Soft Play faci and more recently the "temporary" closure of the climbing wall there too means our children and families have very few opportunities for play and exercise not only now during a difficult lockdown period but also in the future.

Many families in the area have no family or support network locally. Lockdown has affected the mental health of everyone, adults and children, and parents with young children have been struggling especially due to the lack of social interaction. The Marylebone Mums & Dads group is unfortunately unable to hold regular meetups currently but continues to be very active through the multiple social media channels. As well as friendship and fun, the group provides support, advice as well as sharing

information and recommendations for parents and carers in Marylebone. It is a truly supportive community and we welcome new members, especially during this time when we all may need maybe a little extra support to get through the weeks.

Oxford Street - update

We attended an online presentation on the latest Oxford Street District (OSD) plans last week hosted and presented by Councillor Melvyn Caplin and the OSD Project Manager Elad Eisenstein.

WCC is keen to continue with the OSD scheme but with 30 to 40% closures forecas the clear need at present was to develop policies to combat that and pull businesses back in. So there are no imminent plans to go ahead with any road closures on Oxfc Street. For the present WCC wishes to introduce a series of temporary measures in pragmatic approach to develop the street to cope with current demands.

We were given an assurance that we will be consulted prior to the implementation o any of the temporary schemes so they can be discussed beforehand and their consequences assessed prior to their introduction (unlike at Regent Street last year)

It was emphasised that temporary means just that and we took some comfort from t Project Manager's statement that with any of these schemes, temporary or otherwis there is no intention to create any displacement of traffic though the areas surroundi Oxford Street, which is one of our major concerns.

We look forward to attending regular meetings during the course of the year on the Oxford Street proposals and will be keeping members informed of their outcome through the Newsletter.

You have heard of ULEZ, LTN and the C-charge, but is ZETZ the new acronym for London traffic to deal with? The New West End Company is proposing a Zero Emissions Transport Zone by 2025. Should Marylebone be part of this?

Coming Our Way





Is it a giant rubbish bin? No, it's a cycle store, and we just hope that Westminster didn't spend too much on the design.

We can look forward to seeing a considerable number of these grace our streets in the coming months and it is true that the more we are encouraged to cycle the more we need think about cycle parking.

Westminster Council over the last decade has done a good job in finding spaces for cycle hoops all over the borough but still there are not enough spaces and the hoops are neithe secure nor do they provide cover for the bikes. They are essentially intended for destinative cycling for people cycling around the borough and parking for short periods.

Bicycle theft continues to be a serious problem despite magic marking and expensive locl One solution WCC has come up with is the bicycle hanger, which are springing up all ove Marylebone. These are welcome and there are waiting lists for spaces within them.

However, there are two problems here - the first being they are a hideous design. Many parts of Marylebone fall within conservation areas because of our heritage architecture. Could WCC not find a more attractive hanger than this one in Bryanston Square? Perhap competition for a better design is needed. Secondly, they do not hold many bikes.

However, it should not be the sole responsibility of WCC to think of ways of providing mor cycle parking in this more eco era. Around the West End a few outlets like 'Bike Drop' or Spokesafe have started opening up where you can park your bike securely (for a weekly/monthly fee) but these are mostly aimed at the daily commuter with the expensive bike. People still need parking back at home. Many of the mansion blocks do not have bicycle storage for residents – they should try to find a corner for their residents to park th bikes.

Perhaps the lovely garden squares could find a hidden spot to put a secure bike shed for their residents? Offices or blocks of flats could convert some underground parking spaces into secure parking for bikes. Perhaps the Estates could find spaces in underground car parks which could be sealed off and made secure for local residents to rent? Westminster could also be bold and look to examples abroad such as in Tokyo where they do things in style.

More Planning deregulation proposed

Fancy living in your old favourite shoe shop or restaurant? Marylebone could look very different in a few years time with plans to allow shops and any business property to becor residential. The government has taken yet further steps to deregulate the planning system and with it diminish community say in future development.

The latest proposals, the biggest and potentially most radical of the changes yet proposed would see permitted development rights (PDR) extended further to allow business (in the new Class E) to convert to residential without the need for planning permission. Despite the entire justification for it being related to high streets, the rights are not limited to high street properties, but in fact apply to every commercial unit in England wherever situated.

From 1 September last year a commercial, business and service (Class E) use class was introduced to provide "greater flexibility" to move between a wider variety of uses, from banks and restaurants to gyms and crèches, without planning permission.

The government's planning White Paper argued that they wanted to give communities a more meaningful voice in the future of their area. These proposals seem to suggest the government wants to give communities as little voice as possible.

The government is now consulting on their latest proposals: "It is proposed that the right would allow for the change of use from any use, or mix of uses, within the Commercial, Business and Service use class to residential use (C3). The right would replace the currerights for the change of use from office to residential (Part 3, Class O of Schedule 2 to the General Permitted Development Order), and from retail etc to residential (Part 3, Class M the General Permitted Development Order) which remain in force until 31 July 2021."

Pubs, theatres and live music venues would not fall under this use class.

The government has proposed that there should be no size limit on the buildings that can benefit from the right. There is some nominal safeguarding in that certain categories woul require prior approval. These prior approvals would apply to such conversions including flooding, transport and contamination. To ensure appropriate living conditions the prior approvals include the impacts of noise, the provision of adequate natural light, and fire safety.

Unlike the previous planning deregulation measures, these do not exempt conservation areas, with the rather weak exception of the inclusion of some specific prior approval crite allowing councils to consider the impact of the loss of the ground floor use to residential within conservation areas.

Given the impact that Covid 19 and the associated restrictions have had on the economy, there will be a real temptation for commercial landlords to go for a short term gain and change vacant units to residential before looking at other, more traditional, commercial us for them. Even if a business remains it may see their income fall as other businesses in the area, and their employees, leave.

This will not benefit residents as there will be the impact of the loss of valuable community facilities, including shops which meet local needs. We will also see increased demand for remaining facilities. A few small developments may be possible without this impact but if the up is large or large sites are included in these proposals, it could have a substantial advertise impact on our area.

The Association therefore believes that this PDR should not be implemented and has

submitted a response along these lines. However, if it is decided that it makes sense in some parts of the UK, we are of the opinion that it should not apply in London's West End and CAZ area. There may be an argument for it in some parts of the country with derelict and dying high streets, but this is not the position in our area, and we can only see it doing harm by undermining the existing commercial areas. Our area does not need this PDR are there are significant negative consequences associated with its introduction.

Unrestrained development might sound enlightened, but it has been controlled for the pas 100 years for a reason.

TFL lobbies for road charging and reduced bus services

Faced with an ever ballooning debt burden TfL is looking to new forms of income. These are set out in a document commissioned by TfL called 'New Solutions for a Changing City'.

Smart Road Pricing (SRP) is a proposed evolution of the current Congestion Chargi ULEZ and tolling systems (such as DART). In this way TFL would finally abandon the pretence of green levies and switch to a comprehensive tax on all roads within the area of their control, to be paid by all road vehicles with a combustion engine.

Further bus reductions are also proposed. Due to the high fixed cost of rail infrastructure and the relatively low marginal cost of bus operation, "encouraging mc bus users to switch to rail where possible will make more efficient use of the network overall, reduce the cost of bus operation, and release capacity on the road network more active travel."

For this to work, it requires more integration of fares to allow for easier, "multi- moda journeys" based on a simple universal fare structure for all, removing the separate fl bus fare and zonal rail structures. This would require changes to existing fare structures including a single network-wide approach to fares that is harmonised acrobus and rail.

This will have the effect of reducing the scale and cost of bus operation by removing duplication and driving growth in demand for rail services. It will mean bus fares becoming more expensive, offset with concessionary fares targeted at those in greatest need.

TfL Road Closures ruled unlawful

London's mayor took advantage of the pandemic to introduce "unlawful" road closur and cycle lanes, according to a High Court judgment in January .

Dozens of roads were closed and others narrowed to create new cycle lanes last ye in an effort to encourage walking and cycling.

The judgment followed a legal challenge by organisations representing black cab drivers who were angry about being banned from a new bus-only route on the A10 i Bishopsgate. This scheme was part of plans to make the area one of the largest car

free zones in any capital city in the world.

A High Court judge has condemned the Mayor's 'irrational' road closures and pop-up cycle lanes for unfairly excluding taxis, the elderly and disabled

In the judgement, Justice Lang added: 'The scale and ambition of the proposals, and the manner in which they were described, strongly suggest that the Mayor and TfL intended that these schemes would become permanent, once the temporary orders expired."

"However, there is no evidence to suggest that there will be a permanent pandemic requiring continuation of the extreme measures introduced by the Government in 2020."

Justice Lang said the A10 scheme treated cab drivers unfairly and should be abolished. But her judgment also called for an end to the Mayor's wider Streetspace initiative, including the introduction of several hundred miles of temporary cycle lane

The lanes sparked criticism from motorists for increasing congestion, and one on Kensington High Street was removed late last year following a local outcry.

In addition to cycle lanes, Streetspace - which was put in place last May - saw the implementation of bus gates, banned turns and restricted access to streets in Low Traffic Neighbourhoods across London with the aim of encouraging walking and cycling. A similar scheme was proposed by WCC for the Hyde Park Estate but withdrawn after substantial resident opposition as reported in last month's newslette

The Judge found that TfL had also acted unlawfully in respect of the Equalities Act. The Assessment produced by TfL did not meet the required standard of a "rigorous" and "conscientious" assessment conducted with an open mind. Rather, it was "inconsistent and irrationally underrated the risk". As the Judge said, "Most worrying of all, the Equalities Assessment read as if its purpose was to justify the decision already taken".

What is happening in Hyde Park?



The Royal Parks' Movement Strategy was published last year. As part of the Movement Strategy, the Royal Parks are running six-month trials in six of the Royal Parks. They want to hear the views of the people who use these parks and have ar interest in these trials.

- Expanding the regular Sunday motor vehicle restriction on South Carriage Dri to include Saturday
- Motor vehicle restriction introduced on North Carriage Drive
- Creating new park space and improving the park environment for park users
- The roads remain open to all park users on foot or bicycle

The Association shares the concerns of the Hyde Park Estates Residents Association that the closure of North Carriageway Drive will only displace more traffic through residential areas in the Hyde Park Estate, particularly when traffic levels return to normal. We have responded to the consultation accordingly.

Romas move on after 7 years



The Romas have finally left their Park Lane residence, leaving devastation in their wake.

The notorious Illegal camp that was home to beggars and linked to a rise in crime an anti-social behaviour in the local area was finally dismantled in January. Council workers were left to clear piles of rubbish and dismantle tents.

It was by no means the first time groups of people have set up shop on the road, will a group of rough sleepers - believed to be migrants - staying there in July.

In fact the area has been blighted by trouble over a period of some seven years, wit different groups coming and going. Westminster City Council Leader Rachael Robathan said last month that WCC didn't have the legal powers or resources to de with encampments where people refuse or aren't entitled to help and urged Priti Pat to help shut it down. Following this considerable negotiations were undertaken to remove the camp occupants. we understand.

Once the occupants left and abandoned their tents, WCC moved in armed with hear machinery and removal vehicles, to clear up the mess.

It is not known, however, where the group have now moved to.

WCC: Changes at the Top

The following changes to the Cabinet at Westminster City Council have been announced:

Cllr Andrew Smith, current Cabinet Member for Environment & Highways has left the cabinet to focus on other commitments and the top team will reduce in size to eight resulting in a minor realignment of responsibilities. He was thanked for his work to introduce 20mph schemes across the city and, in recent months, his role in delivering the all fresco dining schemes to help hospitality businesses stay open during a difficult period.

Cllr Matthew Green, will combine his existing responsibilities as Cabinet Member for Business and Planning and take on the additional responsibility of Licensing. The Leader says this is designed to ensure Westminster can respond agilely to the difficult circumstances many businesses in the city are facing.

Cllr Melvyn Caplan, will take on an additional role delivering City Management Services, which allows for closer alignment with his existing role in driving forward the Oxford Street plans, Cllr Caplan remains Deputy Leader.

Cllr Paul Swaddle, will take on the Finance & Property brief in additional to his existi role around smart city, digital and customer services.

Cllr Heather Acton will lead a new communities and regeneration portfolio which brir together the programme to deliver new affordable homes with community engagement community protection and police liaison. Cllr Acton will also lead Westminster Connects which has been a lifeline for some of the most vulnerable residents since start of the pandemic.

Leader of Westminster City Council is Cllr Rachael Robathan.



Property investors ended the year with a We End office buying spree

In spite of it looking like a ghost town, the big money appears to be sticking with the West End: property investors flocked to buy West End offices at the end of the year hopes surrounding Covid vaccines improved, with over £1 billion of sales agreed in December. According to data gathered by Savills, West End office transactions in th last three months of 2020 reached £2.9 billion, which is 38% above the five year average for the final quarter.

December's turnover of £1.16 billion across 12 transactions was the highest monthly volume of the year and that this single month was responsible for approximately 25° of the total amount transacted in the West End over the whole of 2020.

Tottenham Court Road Car Ban



And finally, more traffic restrictions - as of today almost all the traffic changes planne under Camden's West End Project will be completed.

A centerpiece of the project is the new, very complicated, motor-traffic restrictions or Tottenham Court Road, with various banned turns that come into force from Monday February. Gower Street will also become two-way for all traffic from February. The traffic changes will also affect Bloomsbury Street, and some parts of High Holborn a Shaftesbury Avenue which were previously one-way and will now become two-way.

When the Monday to Saturday restrictions are in operation, only buses and pedal cycles will be able to travel the whole length of Tottenham Court Road. Drivers of private motor vehicles, including taxis, will be routed either east or west off the stree various points and "sent on a misguided tour of Fitzrovia's narrow, Georgian streetscape before joining Gower Street to escape the chaos". Fitzrovia News.

Or maybe they will end up further afield, in Marylebone for instance, where it is still possible to drive through most of our roads without multiple restrictions.

Whether it's telephone calls from people claiming to be from HMRC regarding outstanding tax; emails allegedly from your bank stating there is problem with your account; text messages allegedly from the NHS offering Covid 19 vaccines for a fee fake websites selling PPE, doorstep callers offering supposedly bargain priced homimprovements or letters from clairvoyants predicting good health or wealth, the scammers aim is to con you and get access to your money or personal details.

Anyone can be a victim of scams. Criminals will exploit everybody, so it is important be on the alert.
